The meeting of the Nebraska Brain Injury Advisory Council commenced at 10:00 a.m.

#### Introductions:

Members, staff and guests introduced themselves.

### Approval Of December 15, 2023 Minutes:

The minutes of December 15, 2023 were reviewed. A motion was made by Carla Lasley and seconded by Michelle Ploeger to approve the minutes. There were no objections, motion carried by unanimous consent.

### Approval Of Agenda:

The Agenda was reviewed and Judy mentioned that Maria and Zaida only have a limited time to speak during the TBI Act Reauthorization and TBI Awareness Day section and recommended that Council Members wishing to speak about the Brain Injury Awareness Activities can speak during the Roundtable section. A motion was made by Madison Wurtele and seconded by Carla Lasley to approve the agenda with the changes. There were no objections, motion carried by unanimous consent.

### Brain Injury State Plan - Keri Bennett

Now that we have the state plan nearly complete we will be posting the final documents and text only documents to the website. We have flexibility to when we can open the plan up for Public Comment. The goal is to do that every 2 years, and we would take some time to work through the Needs Assessment data and post it for public comment by the end of 2024 and potentially make changes going into 2025.

Keri invited members to provide letters of commitment outlining how they support activities in the State Plan. If you have any questions, contact Keri. Keri also provided a call for volunteers to go through the Needs Assessment data when it is available.

# Brain Injury Needs Assessment – Liz Gebhart-Morgan of Partners for Insightful Evaluation (PIE)

Liz provided an update on the 3 surveys that have been launched focusing on rollout, dissemination approach, and next steps.

The rollout was very intentional and broad, with a goal of reaching as many organizations and individuals as possible. A promotional flyer included the link and a QR code to the landing page where all three surveys were available.

Dissemination efforts were strategic and surveys were sent to 190 agencies, including support groups, nonprofits, health department, etc. A priority was to reach out to underserved regions and individuals across the state. The survey was launched and then promoted at the Brain Injury Conference with printed flyers in the attendee packets. Follow up will go out in April with the flexible deadline being April 12<sup>th</sup>.

Responses so far were reviewed, and Liz feels good about where results are at so far.

# TBI Act Reauthorization and TBI Awareness Day activities recap – Maria Crowley and Zaida Ricker of NASHIA

Zaida presented an update and was excited to witness all of the support of the TBI Awareness Day activities by agencies and individuals advocating for reauthorization of the TBI Act and appropriations. The TBI Act is the only federal legislation that directly supports state TBI program efforts. Requested changes include expanding the legislation to include both non-traumatic and traumatic brain injury, and decreasing the required state match amount, which has been a barrier to some states applying for the grants. Work is being done to support the data system so that it provides better information.

The legislation went through and included almost all the changes and will now go to the House and Senate. It is expected to pass. Zaida reminded members to contact their members of congress to support the act.

Maria stated there was an impressive number of people at Capitol Hill supporting the TBI Act, there was a Brain Injury Awareness fair with 27 exhibitors and a lot of representation from veterans.

Jodi shared feedback from the small committee on how we could use the new tool. Members thought the tool should be more visible and available.

Keri reported the committee took a deeper look at the tool, and though it is not required, it was originally developed as a tool for grantee states to gauge and measure their progress in developing TBI program infrastructure. Asked committee to take a deeper look at each question to see where we are with services. Keri proposed that this be a standing item on the agenda to review one or more of the components in each quarterly meeting.

## Mid-Year Report on the Brain Injury Assistance Act- Liz Gebhardt-Morgan on behalf of BIA-NE

Reports-Brain Injury Assistance Act Dollars received by BIA. Primary focus is on resource facilitation.

The 1<sup>st</sup> priority is the growth of the number of resource facilitators providing services across the state. The 2<sup>nd</sup> priority is training for providers. 23 trainings were offered with over 500 individuals trained. See attached report for information on the remaining priorities.

The report goes to the Brain Injury Oversight Committee to demonstrate what resources are being used in supporting the 7 Priorities.

Update on motorcycle helmet law that is in the final reading; it will get rid of educational requirements and will likely pass.

Lb1417- Bill to eliminate or change groups or councils that are not active. The Brain Injury Oversite Committee was included in this bill but an amendment will be made to keep the Committee as is.
