AAA – Area Agency on Aging

ABI - Acquired Brain Injury

ADA - Americans with Disabilities Act. Civil rights act for persons with disabilities.

ADRC – Aging and Disability Resource Center

ARC - Non-profit organization that promotes and protects the human rights of people with intellectual and developmental disabilities.

ATP - Assistive Technology Partnership. A state agency that helps Nebraskan's with disabilities, their families and professionals obtain assistive technology devices and services.

BI - Brain Injury

BIA - Brain Injury Alliance of Nebraska

BIAC - Nebraska Brain Injury Advisory Council

CAP - Client Assistance Program. An advocacy program for clients pursuing VR services.

CIL – Center for Independent Living. Organizations that supports disabled people in their efforts toward independence.

NASHIA – National Association of State Head Injury Administrators – Brain injury policy, program, and service resources assisting state government in promoting partnership and building systems to meet the needs of individuals with brain injury and their families.

NCBVI – Nebraska Commission for Blind and Visually Impaired. Agency that provides vocational rehabilitation services to visually impaired individuals.

NIBN - The Nebraska Injured Brain Network

NIDILRR- National Institute on Disability, Independent Living, and Rehabilitation Research. A federal funding agency that provides leadership and support for research related to the rehabilitation of individuals with disabilities.

NYLC – Nebraska Youth Leadership Council. Statewide council of young people with disabilities between the ages of 14-21.

P & A – Protection & advocacy.

PCP - Person-Centered Planning

PILS - Panhandle Independent Living Services.

QLI – Quality Living Inc.

SEAC- Special Education Advisory Council.

SILC – State Independent Living Council. State Council that promotes Independent Living and facilitates systemic change that promotes independence, inclusion, non-discrimination, and dignity for all people with disabilities.

SPED - Special Education

SRC - State Rehabilitation Council – A statewide advisory council for the Nebraska Vocational Rehabilitation agency.

TARC - TBI Technical Assistance and Resource Center for TBI Grantee States.

TBI – Traumatic Brain Injury

UNMC – University of Nebraska Medical Center

VA – Veterans Administration. Federal agency that administers services to veterans.

VR – Vocational Rehabilitation. Sometimes referred to as Voc. Rehab. Agency that provides employment related services to individuals with disabilities.

WIOA - Workforce Innovation and Opportunity Act. The overall act that contains the Rehabilitation Act.
